First, young professionals are developing relationships that materialize in internships and jobs but second, the College is always augmenting its brand. Most frequently at events, Virginia State University is the only academic institution represented and certainly the sole school represented by students.

Stories conveying how this works and why it's successful are voluminous enough to now write a thousand page book but for the purpose of this newsletter but one has been selected to share. It regards Jhadee Gordon (Accounting graduate, class of 2017). Specifically, Jhadee along with her colleague Monet Graves (Marketing graduate, class of 2017) participated in a networking event in Richmond in 2016 attended by about two dozen business owners. One said owner was Vaughan Long (Owner of Tax Solutions Alliance). Jhadee and Vaughan hit off a terrific conversation with Jhadee impressing him as she does everyone she meets. But wait, the story doesn't stop there. Fast forward, Malaika and Bashirah would eventually go on to new companies, i.e. Malaika at Willbros T&D Services East and Bashirah at Capital One. So, who did Long contact about securing new accountants, you guessed it; the Reginald F. Lewis College of Business. It's why Dennis McRae (Accounting major) has been hired at Tax Solutions Alliance.

The College's commitment to entrepreneurship most recently materialized in a team being assembled to pitch a business idea at the Tom Tom Founders Festival in Charlottesville. Of forty-four teams from around the state that submitted a business idea only fifteen were selected to compete. Comprised of Kiera Anthony, Chanel Brown, Marcus Lowery, Destiny Hodges, and Ai'Jalon McGhee (all Marketing majors) along with Destini Woods (Management major) the team founded the company Solidarity.
